RE: Assembly Bill 1114- Increasing Access to Pharmacist Services in the Medi-Cal Program

Dear Governor Brown:

The Academy of Managed Care Pharmacy (AMCP) urges you to sign Assembly Bill 1114, legislation that would make certain pharmacist provided services a covered benefit under the Medi-Cal program. As health care delivery in the United States continues to evolve and the focus on an interdisciplinary team approach to patient care increases, it is critical to recognize the value of pharmacists as health care providers.

AMCP is a national professional association of pharmacists and other health care practitioners who serve society by the application of sound medication management principles and strategies to improve health care for all. The Academy's nearly 8,000 members, with 1,295 living and practicing in California, develop and provide a diversified range of clinical, educational and business management services and strategies on behalf of the more than 200 million Americans covered by a managed care pharmacy benefit.

The high level of education and training pharmacists receive qualifies them as "medication experts". As pharmacists continue to be recognized for their value as members of a health care team, an expanded role for pharmacists will improve patient outcomes and reduce overall health care costs in the Medi-Cal program. Therefore, patients in the Medi-Cal program will benefit when pharmacists are authorized to enhance patient care by improving patient outcomes, increasing patient satisfaction, improving access to certain services, decreasing the number of drug related adverse events, and reducing overall healthcare costs.¹
