Forum Identifies Opportunities to Improve Patient Financial Burden in Oncology and Shift to Value-Based Care Models



Experts representing managed care pharmacy, providers, patients, biopharmaceutical manufacturers and other stakeholders gathered last month to find solutions to the financial burden of oncology care on patients, while also improving cancer treatment outcomes and advancing the concept of value-based health care. AMCP held a Partnership Forum "Driving Value and Outcomes in Oncology" on Nov. 14 and 15 outside of Washington, D.C. More than 30 experts from across the country discussed topics such as the importance of greater cost transparency for patients, and the need for new quality and value measures. Participants suggested solutions to various factors that lead to patient financial burden in

oncology. They also reviewed the state of oncology quality measures and gaps, and identified specific considerations needed to measure value in cancer care. Read [more](#).

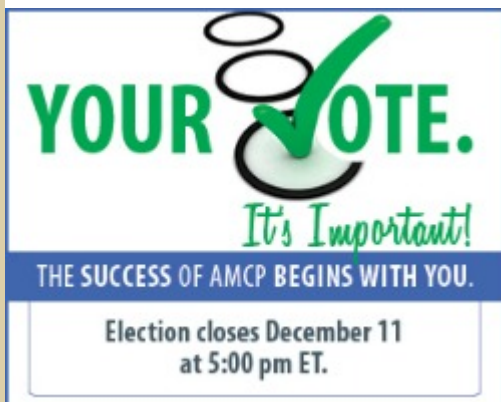


The Strategic Planning Behind AMCP's New Strategic Plan

The Academy will soon unveil a new strategic plan to guide our organization over the next several years. As it's rolled out – more on that next month – I thought I would highlight some of the deliberations that went into developing the plan. The process started with a workshop of AMCP senior staff and volunteer leaders, as well as a few highly regarded outsiders, who examined factors affecting the demand for people and services to manage medication therapies. Our group took a clear-eyed look at all of the major trends affecting our profession, and how AMCP might leverage these to improve the Academy and better serve our members. Specifically, we looked at:

- The growing influence of patients and consumers;
- The burgeoning regulatory environment;
- Health care industry consolidation and business model innovation;
- The increasing challenges of the existing managed care model;
- The rising costs of Rx therapies and changes in drug development; and
- Data, technology, care integration, value and improving health outcomes.

Strategies to Move Forward With Value-Based Contracting Are Laid Out in Proceedings

AMCP has released a consensus document on value-based contracting that includes a key stakeholder definition of VBC along with strategies to implement the innovative payment model. The newly released proceedings of the [AMCP Partnership Forum, "Advancing Value-Based Contracting,"](#) addresses issues discussed at the June 2017 event, including:

- A definition of VBC for facilitating discussion with key policy makers, regulators and other stakeholders;
- Strategies for advancing development and utilization of performance benchmarks;
- Best practices in evaluating, implementing and monitoring VBCs; and
- Action plans to mitigate legal and regulatory barriers to VBCs.

Participants defined VBC: "A value-based contract is a written contractual agreement in which the payment terms for medication(s) or other health care technologies are tied to agreed-upon clinical circumstances, patient outcomes, or measures." One of greatest challenges with a VBC is selecting appropriate outcomes to measure and determining how much value to assign them. Read [more](#)



AMCP Foundation Symposium Report: Stakeholders Express Multiple Perspectives of What Constitutes 'Value' in Delivery of Health Care

The AMCP Foundation has released a [comprehensive summary](#) of concepts of "value" examined at its recent research symposium on "Value-Based Health Care: Identifying Benefits for Patients, Providers and Payers." The event, held near Dallas, Texas, in October, examined perceptions of health care value from many stakeholder perspectives. What one considers "valuable" in any particular therapeutic intervention can vary widely between providers, patients and payers, the expert panelists noted.

"Fully understanding value in health care requires that we develop a standardized process for incorporating the patient perspective into health care decision-making at multiple points in their journey," said Alan Balch, CEO, Patient Advocate Foundation, who presented the keynote address.

CMS's Proposed Rule on Medicare Programs in Contract Year 2019 Incorporates Several AMCP Recommendations

AMCP has released a [summary](#) of the Centers for Medicare and Medicaid Services (CMS) proposed rule titled "Medicare Program; Contract Year 2019 Policy and Technical Changes to the Medicare Advantage, Medicare Cost Plan, Medicare Fee-for-Service, the Medicare Prescription Drug Benefit Programs, and the PACE Program." The proposed rule, released Nov. 16, amends regulations for Medicare Part C and Medicare Part D to implement provisions of the Comprehensive Addiction and Recovery Act (CARA) and the 21st Century Cures Act. The 713-page proposed rule includes several major policy provisions that impact managed care pharmacy, both positively and negatively. Read [more](#).
