




AMCP Educational Affairs Committee Gathers in Alexandria to Discuss Nexus 2018 Sessions

Members of the Educational Affairs Committee and AMCP staff spent two days last month reviewing 50 proposals for educational sessions at AMCP Nexus 2018 in Orlando, Florida. The theme of the October 22-25 conference is "preparing for the next generation of care." The Committee ultimately identified 31 distinct sessions that align with Nexus's main theme and four additional educational tracks (click link below).

"The committee's goal is to create a solid educational framework for Nexus," said Curtis M. Wander, BCPS, PharmD, Chair of the Educational Affairs Committee. "We evaluate each proposal to ensure it meets the needs of AMCP's diverse membership."




Thank You to the Volunteers Who Helped Make Annual Meeting a Success

AMCP Responds to White House Blueprint to Lower Drug Prices and Out-of-Pocket Spending

President Trump last month released a request for information on ways to lower prescription drug costs. The request, which is part of The White House's overall Blueprint to Lower Drug Prices and Out-of-Pocket Spending Costs, includes dozens of suggestions and policy proposals on how stakeholders throughout the health care system can reduce medication costs. Following President Trump's May 11 speech launching the initiative, AMCP CEO Susan A. Cantrell, RPh, CAE issued a statement: "AMCP applauds the Administration for addressing the rising cost of pharmaceuticals. This is an area in which AMCP has been proactively developing solutions to ensure patient access to affordable medications. We are pleased to see momentum building to address these challenges for the 300 million Americans with a prescription benefit that our members represent. AMCP has long supported several of the recommendations contained in the President's blueprint, including the need to foster a competitive generic and biosimilars marketplace, and greater flexibility in benefit design for the Medicare program. However, AMCP also believes some of the elements outlined in the President's blueprint require further consideration and broad stakeholder input to ensure that they are sustainable solutions to decreasing medication costs without resulting in unintended consequences that may disrupt patient care." AMCP-Supported Opioid Management Bills Proceed in House

Several AMCP-supported bills to combat the opioid crisis are scheduled for a full vote by the House of Representatives during the week of June 18. The expected votes come after the House Energy and Commerce Committee last month passed 57 opioid-related bills, including 53 bills approved by bipartisan voice votes and four by roll call votes. AMCP has actively endorsed several of these bills, including through Capitol Hill office visits, letters to Representatives and member engagement via AMCP Action Alerts. The bills are:

- H.R. 3528 Every Prescription Conveyed Securely Act
- H.R. 4275 Empowering Pharmacists in the Fight Against Opioid Abuse Act
- H.R. 4841 Standardizing Electronic Prior Authorization for Safe Prescribing Act of 2018
- H.R. 5795 (formerly H.R. 3545) the Overdose Prevention and Patient Safety Act

AMCP will continue to advocate for passage of these bills. The AMCP Board of Directors earlier this year designated Opioid Management as one of three policy and advocacy focus areas for the Academy in 2018. AMCP Launches APPE Rotation in Association & Leadership Management

The five-week APPE rotation, located at AMCP headquarters in Alexandria, Va., focuses on developing skills such as effective communication, education and advocacy. Below are initial thoughts of the APPE student pharmacists in the inaugural block, both of whom started in May.

Venise Rita De Etoulem, Texas Southern University, Class of 2019: Having started my APPE rotation with AMCP comes as a blessing in disguise. While being different from what I have done so far in my academic career, it forces me to get outside my comfort zone, which allows me to grow every passing day. I have the opportunity to learn about policies and regulations, as well as how they are implemented. What I enjoy the most about this rotation is the fact that every day is different from the previous one: I can work on a project that will help the team in achieving a goal one day and take part in a discussion about the opioid crisis on Capitol Hill on the next one. But

This rotation not only allows me to accrue my knowledge-base but also permits me to develop my leadership skills. From a meeting in a Senator's office on Capitol Hill to discuss the Pharmaceutical Information Exchange Act to a meeting of the Joint Commission of Pharmacy Practitioners on value-based contracting, there has never been a dull moment at this rotation. In just the first two weeks I have gained a deeper understanding of the topics and issues affecting legislative affairs, quality measures, and value assessment frameworks, among many



others. I also have attended many internal and external stakeholder meetings with key thought leaders, trying to determine the best avenue in managing health care cost. AMCP preceptors and staff have been very welcoming and supportive throughout this experience.

Members in Action: LRAC Member Terry Cothran is Panelist in Alliance for Health Policy Event

AMCP member **Terry Cothran**, RPh, Director of Pharmacy Management Consultants, University of Oklahoma College of Pharmacy, served as a panelist at a briefing on State Opportunities to Address Prescription Drug Costs in Medicaid. The event held last month by the Alliance for Health Policy was designed to inform federal policymakers and stakeholders about the legislative and regulatory actions that state officials are perusing to address rising costs of prescription drugs in Medicaid. Panelists outlined the rationale for state legislative and regulatory actions to address the rising cost of prescription drugs in Medicaid, and detailed the mechanisms of state policies, as well as opportunities to leverage flexibility within federal parameters. Cothran serves on the AMCP Legislative and Regulatory Action Committee (LRAC) as well as the State Advocacy Coordinator for Oklahoma. His presentation is available here.

Outcomes-Based Contracting – Views from AMCP eDossier System Payers

Outcomes-based contracting (OBC) involves payers sharing risk with pharmaceutical manufacturers using value-, instead of volume-based payments. Examples of key challenges identified in OBC agreements are establishing a clear framework for these agreements, identifying and applying appropriate research methods, and involving all relevant parties. OBC should be considered when there is uncertainty in clinical or economic outcomes. According to a 2018 survey of US payers registered on the AMCP eDossier System @FormularyDecisions.com®, with 128 respondents, 68% of payers indicated their organization would consider entering into OBC with a manufacturer, yet only a third of respondents have direct experience with OBC. While payers feel that these contracts can be attractive (such as paying for value), they also express concerns (such as data monitoring and reporting).
