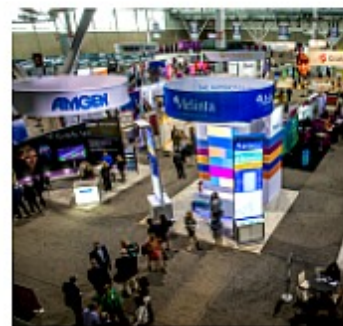

## AMCP and AMCP Foundation Leaders Approve Joint Research Agenda

The AMCP Board of Directors and Foundation Trustees (*pictured above*) last month approved a four-part research agenda that will identify and prioritize critical evidentiary gaps in managed care pharmacy. The agenda was proposed by the AMCP & AMCP Foundation Joint Research Committee (JRC), which was established in 2016 to promote and encourage the creation and dissemination of relevant and credible research and initiatives to advance patient care services in managed care pharmacy. The four research priority areas are:

1. Real world evidence to inform managed care pharmacy decision-making;
2. Value-based models in managed care pharmacy to address total cost of care;
3. Impact of benefit design or utilization management strategies on patient outcomes; and
4. Impact of direct patient care services provided by managed care pharmacy on patient outcomes.

More details will be published in an upcoming issue of the *Journal of Managed Care & Specialty Pharmacy*.



## University of North Carolina at Chapel Hill Wins 2018 National P&T Competition

For the second year in a row, the University of North Carolina at Chapel Hill Eshelman School of Pharmacy won the top spot in the AMCP Foundation National Student Pharmacist Pharmacy & Therapeutics (P&T) Competition. The awards were announced April 26 at the AMCP Annual Meeting in Boston. This year, 60 AMCP Student Pharmacist Chapters nationwide participated. The 2018 winning teams are: **First Place:** University of North Carolina at Chapel Hill Eshelman School of Pharmacy; **Second Place:** University of Illinois at Chicago College of Pharmacy; and **Third Place:** The Ohio State University College of Pharmacy. ## Specialty Connect: Focus on Hemophilia Draws Large Attendance

More than 200 people attended this year's Specialty Connect: Focus on Hemophilia, held April 23 prior to the Annual Meeting in Boston. The event focused on the clinical and economic complexities surrounding the treatment of hemophilia through four in-depth sessions:

- The Present and Future of Hemophilia Treatment
- Managing Patients with Hemophilia: A Payer's Perspective

- Gene Therapy for Hemophilia: Hope for a Cure?
- Perspectives in Hemophilia Management: A Panel Discussion

AMCP President Diana Brixner opened the session, noting that the Connect programs have become an important component of the Annual Meeting in recent years. “Specialty medications, as we know, remain the fastest-growing sector of the pharmaceutical industry, and continue to be the primary driver of pharmacy spending,” she said. The event was moderated by Susan Winckler, Chief Risk Management Officer of Leavitt Partners. The educational programming for Specialty Connect was developed through independent grants from CSL Behring LLC, Novo Nordisk Inc., and Shire.



## Student Pharmacists Took Advantage of Annual Meeting’s Special Programming

The AMCP Annual Meeting in Boston provided ample programming for student pharmacist members. Targeted sessions included those on the importance of patient reported outcomes, and innovations in medication therapy management.
