

Medication Recycling Bill HF 2987/SF 2562 University of Minnesota College of Pharmacy

Project Description and Implementation Overview

Twenty states in the US have comprehensive medication recycling programs, and thirteen states have cancer repositories – including Minnesota. All thirteen of these cancer repositories are non-operational, however the states with more general medication recycling have had great successes. A dedicated group of 3 students worked to introduce a medication repository bill to the 2018 Minnesota legislative session. This was achieved through researching medication recycling programs across the US, speaking with various mentors across the field of pharmacy for guidance, meeting with stakeholder organizations, meeting with members of congress to identify authors and gaining the MN Board of Pharmacy's support.

One very rewarding aspect of this project was sharing our process with our peers to show how possible it is to change laws as a student, and provide motivation to peruse advocacy measures. We presented the topic of medication recycling, the process of how to create a bill to bring to congress, and the progress we've made as a committee.

Purpose of the Project

- Lower the cost of medications for uninsured or underinsured Minnesotans.
- Improve health outcomes of Minnesota residents due to increased medication adherence due to higher medication availability and lower costs.
- Lower the overall healthcare cost to the state by reducing healthcare problems related to adherence
- Removes pollutants from environment

Project Budget: Expenses and Revenues

Through printing sell-sheets and research materials for presentations we spent \$100 of our own money over the past 9 months. No other direct costs were associated with this project.

Who and How Many Chapter Members are Involved?

The Public Health Advocacy Committee presented to ~300 U of MN pharmacy students and ~35 AMCP students. There were 5 AMCP members who acted as the grassroots forces to reach out to members of congress to request hearings. The committee is made up of Hannah Van Ochten of AMCP- University of Minnesota Student Chapter, Rowan Mahon of the Public Health Advocacy Student Alliance and Emily Klein of the College of Medicine.

The 2018 Minnesota Legislative Session is still underway. As for all supporters, classmates and mentors, we have been continuously updating them on our progress and identifying ways for them to get involved through calls to representatives and senators.

Speaking to a variety of organizations and seeking mentorship in U of MN faculty and MN members of congress. By meeting with such a wide range of people, we were able to receive a lot of guidance and feedback in planning future steps. We came to every meeting with faculty, member of congress, pharmacy student and stakeholder organization prepared with facts and passion.

What didn't work?

We didn't gain enough support from peers and professionals. Whether this bill passes into law or not, we hope to further our grassroots efforts by building a stronger base of students and professionals to make calls, write pieces for the press, and arrange meetings to really get the word out about medication recycling. Whether that is to pass this bill into law, or to get long term care facilities, nursing homes, clinics and pharmacies to participate – we need to work on building a stronger network to support our efforts. As this bill has typically been passed by nurses, we hope to find more nursing students and organizations to work with along the way.

- Reach out to patients who could benefit from this program, and the providers and professionals that care for them

If Bill Doesn't Pass:

- o Reach out to Minnesota press to promote coverage of medication recycling
- Grow stronger base of student and professional support through presentations and marketing
- Find additional stakeholder organizations to sign letters of support
- Continue to work with current authors in house and senate to keep this bill on their minds
