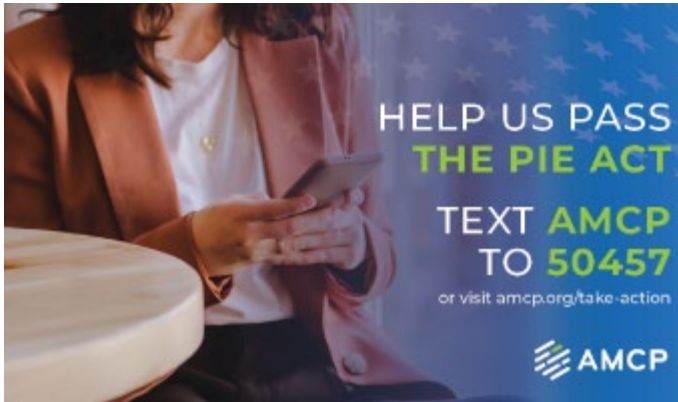

Let your Members of Congress know you support Pre-approval Information Exchange (PIE) as included in the Food & Drug Amendments of 2022 (H.R. 7667). PIE, one of AMCP's top federal priorities, is an important bipartisan policy that will enhance patient access to emerging pharmaceuticals and devices by authorizing pharmaceutical manufacturers to proactively share certain health care economic and scientific information about products with health payers ahead of Food & Drug Administration (FDA) approval.
